WHEREAS, the application concerns property known as Section 39.82, Block 2, Lot 117 on the Tax Map of the Town of Ulster (the "Project Site"). The Project site is situated on New York State Route 9W in close proximity to New York State Route 209; and

WHEREAS, the affiliates and principals of the applicant are qualified individuals with substantial experience in financing, developing, and operating entertainment, restaurant, and hotel facilities; and

WHEREAS, the residents of Ulster County would welcome the job opportunities, increased local spending, and economic and community benefits that would most assuredly derive from such a hotel; and

WHEREAS, the Ulster County Legislature recognizes the uniqueness of the Project Site, the qualifications of the applicant, and the opportunity the Project Site represents to the Town of Ulster; and

WHEREAS, by encouraging the development and operation of the hotel at the Project Site, the Town of Ulster and the County of Ulster can expand their tourism base by providing services and overnight accommodations for visitors as part of a balanced economy and can expand the tax base of the Town; and

WHEREAS, the Ulster County Legislature believes that the development and operation of the hotel at the Project Site would have a positive impact on the Kingston City School District and surrounding communities through the increase of property tax revenues and the expansion of employment opportunities for the citizens of Ulster County, New York; now, therefore be it
