WHEREAS, this resolution has been submitted at the request of the Ulster County Sheriff; and

WHEREAS, the Ulster County Sheriff's Office has secured a public protection grant in the amount of \$ 3,500.00 from New York Governor's Traffic Safety Committee for the term of October 1, 2021 to September 30, 2022, funded by the New York State Department of Motor Vehicles; and

WHEREAS, the grant funds will be used to reimburse the County Budget Lines where the expenses are incurred for child safety seat installation and education; now, therefore be it

RESOLVED, that the Chair of the Ulster County Legislature is hereby authorized to sign an agreement accepting a Governor's Traffic Safety Committee Grant, Child Passenger Safety Program, secured by New York State Department of Motor Vehicles,
