WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of the Department of Public Works; and

WHEREAS, Capital Project No. 519 was established pursuant to Resolution No. 95 dated March 20, 2018, in the amount of \$250,000.00 for energy efficiency and renewable energy projects at the Ulster County Law Enforcement Center; and

WHEREAS, a September 2018 Resolution amended Capital Project No. 519 to include funds for a flex tech study, in the amount of \$31,000.00, bringing the total project cost to \$281,000.00; and

WHEREAS, a May 2019 Resolution amended Capital Project No. 519 to include funds for a natural gas line extension from County Route 32 to the Ulster County Law Enforcement Center, in the amount of \$242,000.00, bringing the total project cost to \$523,000.00; and

WHEREAS, a February 2020 Resolution amended Capital Project No. 519 to include funds for construction of piping from the new natural gas main to the boilers at the Ulster County Law Enforcement Center, in the amount of \$108,000.00, bringing the total project cost to \$631,000.00; and

WHEREAS, the Department of Public Works desires to enter into a design contract to replace the Ulster County Law Enforcement Center boilers with energy efficient equivalents; and

WHEREAS, the Commissioner of Public Works requests that Capital Project No. 519 be amended to increase the funding available for design services for boiler replacement in the amount of \$54,000.00; now, therefore be it
