WHEREAS, the ARPA further seeks to replace lost public sector revenue to strengthen support for vital public services and help retain jobs; and

WHEREAS, the ARPA also seeks to support immediate economic stabilization for households and businesses; and

WHEREAS, Resolution 333 on August 17, 2021, amended the 2021-2026 Ulster County Capital Program to create Capital Project #599 – ARP Non-Profit, Youth and Community Programs, Capital Project #600 – ARP Food Security and Access and Capital Project #601 – ARP Small Business and Economic Recovery; and

WHEREAS, it is more fiscally transparent that these projects be accounted for in the Ulster County operating budget; now, therefore be it
