So, Manna, each, each one of the resumes, if we'll read them, I mean, they all have specific areas that their expertise in I mean, what, from what I've read on them? And are we going to be able to ask them any questions about their resume, specifically what they sent it? Because our resumes that one guy is very, very familiar with solar energy, but not a whole lot of other stuff. According to his resume. one guy's mentioned biomass, which is really kind of integral to what we're doing, I guess, are possible. Um, I just think that we, there's some we should have some leeway in that.

But Donna's resume, well, it's not a resume, it's a letter, which pretty well explains everything she's got in there. And, and I gotta be honest, we I know we have people coming in. But I'm still a little, I have my misgivings about Donna only because of the date that she sent it in. Although her experience is great, I think it's wonderful. And she'd be a great asset.
